### Proceedings of the American Mathematical Society

The PROCEEDINGS of the American Mathematical Society is devoted entirely to research in pure and applied mathematics, and the publication of original papers of moderate length. Articles for insertion should be typewritten and double spaced. Ditto is not generally satisfactory, although other modes of multiple reproduction may be. The maximum length of an acceptable paper is about 8 printed pages. (Since a page of the PROCEEDINGS contains about 400 words, a rule of thumb is that under 10 typed pages is probably within the limit, but that over 12 typed pages is probably too long.) The Manual for Authors, available from the Society, should be consulted for symbols and style conventions. The authors should keep a complete copy of the manuscript, and should take the greatest possible care in preparing the original manuscript; hand

drawn mathematical symbols are entirely satisfactory, if clearly done. Very short notes (not to exceed 1 printed page) of an unusual nature are also ac-cepted, and appear under the heading SHORTER NOTES. (Items deemed suitable include an elegant new proof of an important and well known theorem, an illuminating example or counterexample, or a striking synthesis of familiar results.)
